THE NEW DATES FOR QUARTERLY PAYMENTS ARE: The last day of the month following the last day of calendar quarter.

**These changes apply to the QUARTERLY WITHHOLDING PAYMENTS ONLY**

- 1st Quarter withholding period January, February and March . . . . . Due April 30, 2022
- 2nd Quarter withholding period April, May and June . . . . . Due July 31, 2022
- 3rd Quarter withholding period July, August and September . . . . . Due October 31, 2022
- 4th Quarter withholding period October, November and December . . . . . Due January 31, 2023
