

RESOLUTION NO. R22-03

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL
ESTABLISHING THREE PUBLIC PLACES TO POST
PUBLICATIONS IN ACCORDANCE WITH SECTION 10-8
“PUBLICATION” OF THE TROTWOOD CITY CHARTER.**

WHEREAS, Section 10-8 “Publication” of the Trotwood City Charter authorizes the City to publish all legislation and proposed legislation, public hearing notices, and all other matters and events requiring publication by the City by utilizing two of the three following methods, unless publication by another method is required by the general laws of the State of Ohio, the Ohio Constitution, other provisions of the Trotwood City Charter, or the Trotwood Codified Ordinances:

- (1) by publication on the City’s website for a period of time not less than one week;
- (2) by posting the item to be published in not less than three public places, which public places are determined by counsel, for not less than one week; or
- (3) by publishing the item in a newspaper of general circulation; and

WHEREAS, City Council hereby intends to establish the three public places where publication can be made by the City pursuant to Section 10-8 “Publication” of the Trotwood City Charter.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE
CITY OF TROTWOOD, STATE OF OHIO:**

SECTION I:

In accordance with Section 10-8 “Publication” of the Trotwood City Charter, City Council hereby determines that the following public places will be utilized for any publication required by the City, unless publication by some other method is required by the general laws of the State of Ohio, the Ohio Constitution, other provisions of the Trotwood City Charter, or the Trotwood Codified Ordinances:

- (1) The Trotwood Government Center;
- (2) The U.S. Post Office in Trotwood; and
- (3) The Dayton Metro Library – Trotwood Branch.
