

ORDINANCE NO. OR06-22

AN ORDINANCE BY THE TROTWOOD CITY COUNCIL TRANSFERRING OWNERSHIP OF THE CITY-OWNED PROPERTY KNOWN AS 104 EAST MAIN STREET, PARCEL NO. H33 00301 0001, TO THE TROTWOOD COMMUNITY IMPROVEMENT CORPORATION AND DECLARING THE PROPERTY SURPLUS.

WHEREAS, the Trotwood Community Improvement Corporation (“TCIC”) is the designated development agency working on behalf of the City of Trotwood to create development opportunities in the Trotwood Community; and

WHEREAS, the City of Trotwood and the TCIC have an opportunity to encourage reutilization of the above-described property situated in the City of Trotwood; and

WHEREAS, the City Council wishes to transfer the property known as 104 East Main Street, Parcel No. H33 00301 0001, from the City of Trotwood to the TCIC; and

WHEREAS, the City Council has determined that the property known as 104 East Main Street, Parcel No. H33 00301 0001, is surplus property.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council hereby authorizes the transfer of property known as 104 East Main Street, Parcel No. H33 00301 0001, from the City of Trotwood to the TCIC and further authorizes the City Manager to take any and all steps necessary to transfer this property.

SECTION II: City Council declares this property known as 104 East Main Street, Parcel No. H33 00301 0001, surplus property.

SECTION III: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including but not limited to, Section 121.22 of the Ohio Revised Code.
