

RESOLUTION NO. R22-20

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH PLAYGROUND EQUIPMENT SERVICES FOR RESURFACING AT JOHN WOLFE PARK AND NORTH BROADWAY PARK UNDER A SOURCEWELL COOPERATIVE PURCHASING AGREEMENT, CONTRACT #010521-LTS-3, FOR THE TOTAL SUM OF \$136,962.00, TO BE PAID FOR WITH GRANT FUNDS IN THE AMOUNT OF \$95,684.40 FROM THE MONTGOMERY COUNTY SOLID WASTE DISTRICT AND THE MINIMUM REQUIRED MATCH OF 30% FROM THE CITY OF TROTWOOD.

WHEREAS, the City of Trotwood was awarded a grant from the Montgomery County Solid Waste District to replace the deteriorating rubber surfacing and woodchips under the playground equipment at John Wolfe Park and North Broadway Park; and

WHEREAS, this resurfacing project can be completed by Playground Equipment Services under a Sourcewell Cooperative Purchasing Agreement, Contract #010521-LTS-3, for a contract price of \$136,962; and

WHEREAS, the City Manager recommends that City Council authorize the City Manager to enter into a Contract with Playground Equipment Services to replace the deteriorating rubber surfacing and woodchips under the playground equipment at John Wolfe Park and North Broadway Park.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council authorizes the City Manager to enter into a Contract with Playground Equipment Services to replace the deteriorating rubber surfacing and woodchips under the playground equipment at John Wolfe Park and North Broadway Park, for a total sum of \$136,962.00, to be paid for with grant funds in the amount of \$95,684.40 from the Montgomery County Solid Waste District, and the required match of not less than 30% of the total grant award amount from the City of Trotwood.

SECTION II:

Funds have been appropriated in an amount sufficient to pay the authorized contract amount.


