

RESOLUTION NO. R22-28

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A STRATEGIC PLANNING SESSION BY THE TROTWOOD FIRE AND RESCUE DEPARTMENT ON FRIDAY, MAY 13, 2022 AT THE TROTWOOD COMMUNITY AND CULTURAL ARTS CENTER, WHICH SERVES A VALID PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED ONE THOUSAND DOLLARS (\$1,000).

WHEREAS, the Trotwood Fire and Rescue Department is working towards accreditation through the Center for Public Safety Excellence; and

WHEREAS, a Strategic Plan is required as part of the accreditation process, and such plan requires community input as it is a critical component of evaluating the services provided by the Trotwood Fire and Rescue Department; and

WHEREAS, the Trotwood Fire and Rescue Department has scheduled a Strategic Planning Session on Friday, May 13, 2022 from 8:00 a.m. to 5:00 p.m. at the Trotwood Community and Cultural Arts Center to receive input from residents, community leaders, business owners, and other external stakeholders, which helps foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby determines that a Strategic Planning Session by the Trotwood Fire and Rescue Department as part of the accreditation process be scheduled on Friday, May 13, 2022 from 8:00 a.m. to 5:00 p.m. at the Trotwood Community and Cultural Arts Center, which helps foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II:

The Trotwood City Council hereby authorizes expenditures not to exceed One Thousand Dollars (\$1,000) to purchase refreshments, flyers, and other necessary supplies for the session. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

SECTION III:

This Resolution shall take effect and be in full force from and after the date of its passage.
