

**RESOLUTION NO. R22-34**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT TO PURCHASE FOUR STAINLESS WARREN DUMP BODIES WITH SNOW DOGG SNOWPLOWS FROM K.E. ROSE COMPANY THROUGH THE SOURCEWELL GOVERNMENT PURCHASING PROGRAM, CONTRACT #080818-BPC, NOT TO EXCEED \$332,800.00.**

**WHEREAS**, the dump bodies with snowplows utilized by the Trotwood Public Works Department are at the end of their service life; and

**WHEREAS**, the City of Trotwood Public Works Department needs four (4) new dump bodies with snowplows for the continuation of the high degree of service it provides to the citizens of the City of Trotwood; and

**WHEREAS**, this equipment can be purchased from K.E. Rose Company through the Sourcewell Government Purchasing Program, Contract #080818-BPC with Buyers Products Co., for an amount not to exceed \$83,200.00 each, for a total sum of \$332,800.00; and

**WHEREAS**, funds in an amount not to exceed the authorized purchase price have been appropriated and are in the process of being collected.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council authorizes the City Manager to enter into an agreement with K.E. Rose Company for the purchase of four (4) Stainless Warren Dump Bodies with Snow Dogg Snowplows. This agreement shall be in accordance with the Sourcewell Government Purchasing Program, Contract #080818-BPC with Buyers Products Co., and shall be in an amount not to exceed \$332,800.00.

**SECTION II.** Funds have been appropriated in an amount not to exceed the authorized purchase price and are in the process of being collected.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.


