

RESOLUTION NO. R22-52

A RESOLUTION BY THE TROTWOOD CITY COUNCIL APPOINTING KENTON B. CURTIS, JR. TO THE CIVIL SERVICE COMMISSION FOR THE CITY OF TROTWOOD, STATE OF OHIO, FOR THE REMAINDER OF THE UNEXPIRED TERM OF FORMER MEMBER NANCY MARINO.

WHEREAS, the City Charter established a Civil Service Commission consisting of five (5) qualified electors of the Municipality appointed by the majority vote of Council; and

WHEREAS, the Council has an obligation to appoint members to such Board for a five-year term, without compensation, and subject to obligations, powers, and duties as set forth in the Charter and the Trotwood Codified Ordinances; and

WHEREAS, by prior legislation, Resolution R20-30, Nancy Marino was appointed to serve on the Civil Service Commission for a five-year term commencing March 2, 2020 and ending March 24, 2025; and

WHEREAS, Ms. Marino passed away on January 24, 2021; therefore, City Council must appoint a qualified elector of the City of Trotwood to serve on the Civil Service Commission for the remainder of the unexpired term of Ms. Marino.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council respectfully acknowledges that Nancy Marino passed away on January 24, 2021.

SECTION II: Kenton B. Curtis, Jr., a qualified elector of the City of Trotwood, Ohio, is hereby appointed to serve as a member of the Civil Service Commission for the remainder of the unexpired term of Ms. Marino. Accordingly, Mr. Curtis shall serve on the Civil Service Commission beginning October 3, 2022 and ending March 24, 2025.

SECTION III: Mr. Curtis shall be administered his Oath of Office at such time that is mutually convenient for said elector and the Mayor.

SECTION IV: This Resolution shall take effect and be in force from and after the date of its passage.
