

RESOLUTION NO. R22-55

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH MOTOROLA SOLUTIONS FOR THE PURCHASE OF 43 PORTABLE (HANDHELD) RADIOS, EACH WITH TWO BATTERIES, A SHOULDER MICROPHONE, AND A CHARGER, ALONG WITH 22 MOBILE RADIOS, FOR THE TOTAL SUM OF \$364,724.31, TO BE PAID FOR WITH GRANT FUNDS IN THE AMOUNT OF \$323,170.90 FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY ASSISTANCE TO FIREFIGHTERS GRANT, AND THE MINIMUM REQUIRED MATCH OF 10% FROM THE CITY OF TROTWOOD.

WHEREAS, the City of Trotwood was awarded a Federal Emergency Management Agency Assistance to Firefighters Grant to purchase mobile and portable radios for the Trotwood Fire and Rescue Department; and

WHEREAS, this equipment can be purchased from Motorola Solutions under a Sourcewell Cooperative Purchasing Agreement, Contract #042021-MOT, for a contract price of \$364,724.31; and

WHEREAS, the City Manager and the Fire Chief recommend that City Council authorize the City Manager to enter into an Agreement with Motorola Solutions for the purchase of mobile and portable radios for the Trotwood Fire and Rescue Department.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The Trotwood City Council authorizes the City Manager to enter into an Agreement with Motorola Solutions for the purchase of 43 portable (handheld) radios to include two batteries, a shoulder microphone, and a charger, and 22 mobile radios for the Trotwood Fire and Rescue Department for a total sum of \$364,724.31, to be paid for with grant funds in the amount of \$323,170.90.00 from the Federal Emergency Management Agency Assistance to Firefighters Grant and the minimum required match of 10% from the City of Trotwood.

SECTION II: Funds have been appropriated in an amount sufficient to pay the authorized contract amount.
