

**RESOLUTION NO. R22-57**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY-SPONSORED VETERANS DAY CEREMONY TO SERVE THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED THREE HUNDRED DOLLARS (\$300.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations by City-sponsored activities; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

**WHEREAS**, in observation of Veterans Day, the City of Trotwood will honor veterans in the community during a ceremony to be held on Friday, November 11, 2022 at 11:00 a.m. at the Trotwood Community and Cultural Arts Center, to thank our veterans for their service to our country and to serve the public purpose of promoting strong community relations.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council hereby determines that the Veterans Day Ceremony is a City-sponsored event intended to honor our veterans and serve the valid public purpose of fostering strong community relations, which serves a valid public purpose in the State of Ohio.

**SECTION II:** The Trotwood City Council hereby authorizes expenditures not to exceed Three Hundred Dollars (\$300.00) to purchase light refreshments, a medal for the featured speaker(s), and certificates for all veterans in attendance. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
