

RESOLUTION NO. R22-75

A RESOLUTION BY THE TROTWOOD CITY COUNCIL RECOGNIZING THAT THE CITY-SPONSORED 937 DJ SHOWCASE EVENT CONDUCTED ON AUGUST 14, 2022, SERVED THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, AND THAT THE EXPENDITURES OF TWO THOUSAND SIX HUNDRED AND TWENTY DOLLARS (\$2,620.00) WAS A VALID PUBLIC EXPENDITURE.

WHEREAS, the Trotwood City Council recognizes the importance of reinforcing strong community relations by City-sponsored activities; and

WHEREAS, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, on August 14, 2022, at Madison Park, located at 301 South Broadway Street, the City of Trotwood held a 937 DJ Showcase event that provided an evening of music and dancing for the community, which served a valid public purpose in the City; and

WHEREAS, prior to the event, Council had not approved the expenditure of public funds for the event; and

WHEREAS, Council hereby recognizes that the expenditure of Two Thousand Six Hundred and Twenty Dollars (\$2,620.00) was a valid expenditure and would have been approved on request prior to the event.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The Trotwood City Council hereby determines that the 937 DJ Showcase was a City-sponsored event that helped to foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II: The Finance Department determined, after the event, that expenditures totaled Two Thousand Six Hundred and Twenty Dollars (\$2,620.00) and is requesting that City Council authorize the expense.
