

RESOLUTION NO. R22-76

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING AN EMPLOYEE APPRECIATION HOLIDAY LUNCHEON TO SERVE THE PUBLIC PURPOSE OF ACKNOWLEDGING THE EXEMPLARY PERFORMANCE OF THE CITY'S EMPLOYEES, WITH EXPENDITURES NOT TO EXCEED ONE THOUSAND DOLLARS (\$1,000.00).

WHEREAS, on Tuesday, December 20, 2022 at the Trotwood Community and Cultural Arts Center, the Trotwood City Council will hold their 1st Annual Employee Appreciation Holiday Luncheon to show their appreciation for the City's dedicated public service employees and their exemplary performance throughout the year, which serves a valid public purpose in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby determines that the 1st Annual Employee Appreciation Holiday Luncheon event is a City-sponsored event intended to serve the public purpose of acknowledging the exemplary performance of the City's employees in order to promote retention and enhance recruitment, which serves a valid public purpose in the State of Ohio and in the City.

SECTION II:

The Trotwood City Council hereby authorizes expenditures not to exceed One Thousand Dollars (\$1,000.00) for meat and cheese trays, bottled water, and other necessary supplies for this event. City Council further authorizes the City Manager to take all steps necessary to sponsor this event.
