

RESOLUTION NO. R23-22

A RESOLUTION BY THE TROTWOOD CITY COUNCIL ACCEPTING THE BID OF NEYRA CONSTRUCTION, INC., DBA NEYRA PAVING, FOR RESURFACING WORK TO BE COMPLETED ON THE EAST PARKING LOT OF THE TROTWOOD COMMUNITY AND CULTURAL ARTS CENTER; AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE THIS PORTION OF THE 2023 PAVING PROGRAM FOR AN AMOUNT NOT TO EXCEED \$84,337.60, WHICH IS THE CONTRACT PRICE OF \$76,670.55, PLUS A CONTINGENCY AMOUNT EQUAL TO 10% OF THE TOTAL CONTRACT PRICE, OR \$7,667.05.

WHEREAS, the City is resurfacing the East Parking Lot of the Trotwood Community and Cultural Arts Center in the City; and

WHEREAS, the City properly advertised the 2023 Paving Program resurfacing project as required by law and the bid of Neyra Construction, Inc., DBA Neyra Paving (“Neyra Paving”), was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Public Works Project Manager recommend that City Council authorize the City Manager to enter into an agreement with Neyra Paving to complete the work necessary for the above-described resurfacing project for an amount not to exceed \$84,337.60, which is the contract price of \$76,670.55, plus a contingency amount equal to 10% of the total contact price, or \$7,667.05.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City solicited bids for the 2023 Paving Program and this portion of the project includes resurfacing work to be completed on the East Parking Lot of the Trotwood Community and Cultural Arts Center.

SECTION II: The bids were reviewed and the City Manager and Public Works Project Manager recommend that City Council accept the bid of Neyra Paving for the above-described resurfacing work.

SECTION III: City Council finds that the bid of Neyra Paving was the lowest and best bid submitted and, therefore, accepts the same.

SECTION IV:

City Council authorizes the City Manager to enter into an agreement with Neyra Paving to complete the work necessary for the above-described resurfacing project for an amount not to exceed \$84,337.60, which is the contract price of \$76,670.55, plus a contingency amount equal to 10% of the total contact price, or \$7,667.05.

SECTION V:

Funds have been appropriated in the Community and Cultural Arts Center Fund (Fund 610) or are in the process of collection in an amount sufficient to pay the authorized contract amount.

SECTION VI:


This Resolution shall take effect and be in full force from and after the date of its passage.
