

RESOLUTION NO. R23-27

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED EVENT IN RECOGNITION OF MOTHER’S DAY, WHICH SERVES A VALID PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED THREE HUNDRED DOLLARS (\$300.00).

WHEREAS, the Trotwood City Council recognizes the importance of reinforcing strong community relations by City-sponsored activities and events; and

WHEREAS, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, the City of Trotwood will partner with the Trotwood Chamber of Commerce to host a Mother’s Day Brunch on Friday, May 12, 2023, which serves a valid public purpose in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The Trotwood City Council hereby determines that partnering with the Trotwood Chamber of Commerce to host a Mother’s Day Brunch shall be a City-sponsored event, which helps foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II: The Trotwood City Council hereby authorizes expenditures not to exceed Three Hundred Dollars (\$300.00) to cover the cost of admission for ten mothers and appreciation gifts for those nominated as a special mother. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

SECTION III: This Resolution shall take effect and be in full force from and after the date of its passage.
