

RESOLUTION NO. R23-37

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED BANQUET TO CELEBRATE THE ONE-YEAR ANNIVERSARY OF THE FIRE AND RESCUE DEPARTMENT'S EXPLORER POST 4024, WHICH SERVES A VALID PUBLIC PURPOSE OF ENHANCING EMPLOYEE RECRUITMENT WHILE PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00).

WHEREAS, the Explorer Program is open to young males and females from the age of 14 to 21 who have an interest in learning more about a career in fire science. The Program provides members with first-hand training and experience through exciting activities and mentorship as they look to discover their future, which could possibly be to serve the residents of the City of Trotwood in a career with the Fire and Rescue Department; and

WHEREAS, the Trotwood Fire and Rescue Department welcomed their first class of Cadets to Explorer Post 4024 on September 1, 2022 and the department would like to recognize their dedication and commitment, and review their experiences during a banquet with their families; and

WHEREAS, City Council recognizes the importance of acknowledging and encouraging young males and females to explore careers of interest while creating opportunities to introduce them to public service, enhancing employee recruitment, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, the Fire and Rescue Department will hold a banquet to celebrate the Explorer Program's one-year anniversary while recognizing cadets as they develop into responsible and productive citizens, which serves a valid public purpose in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby determines that a banquet for the Explorer Cadets and their families to celebrate the Fire and Rescue Department's Explorer Program's one-year anniversary is a City-sponsored event intended to serve the public purpose of enhancing employee recruitment while promoting strong community relations, which serves a valid public purpose in the State of Ohio and in the City.
