

**ORDINANCE NO. OR28-23**

**AN ORDINANCE BY THE TROTWOOD CITY COUNCIL REPEALING SECTION 705.09 “BUSINESS LICENSE FEE SCHEDULE” OF THE TROTWOOD CODES OF ORDINANCES AND ENACTING NEW SECTION 705.09 “BUSINESS LICENSE FEE SCHEDULE” TO ADD FOOD TRUCK AND MOBILE VENDORS TO THE CITY’S BUSINESS LICENSES, AND DECLARING AN EMERGENCY.**

**WHEREAS**, a Business Registration Certificate is required by Food Truck and Mobile Vendors to operate within the City of Trotwood; and

**WHEREAS**, The City of Trotwood Planning and Development Department Director recommends City Council repeal Section 705.09 “Business License Fee Schedule” of the Trotwood Codes of Ordinances and adopt new Section 705.09 “Business License Fee Schedule” to add Food Truck and Mobile Vendors to the Fee Schedule, which fee shall be set forth in the City of Trotwood Table of Fees established by Resolution of Council; and

**WHEREAS**, City Council accepts the recommendation of the Planning and Development Director and, therefore, will repeal Section 705.09 of the Trotwood Codes of Ordinances as set forth herein.

**WHEREAS**, City Council has determined that for the preservation of the peace, health, safety, and welfare of the residents of the City of Trotwood and to promote efficiency in the City’s governmental operations, it is necessary that this Ordinance take immediate effect.

**NOW, THEREFORE, BE IT ORDAINED BY A VOTE OF FIVE (5) MEMBERS OF THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** Section 705.09 “Business License Fee Schedule” of the Trotwood Codes of Ordinances is hereby repealed in its entirety.

**SECTION II:** A new Section 705.09 “Business License Fee Schedule” is hereby enacted as set forth in Exhibit “A”, which is attached hereto and incorporated herein by reference, with additions in **bold** and underscoring and deletions in ~~strikethrough~~.

**SECTION III:**

It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including but not limited to Section 121.22 of the Ohio Revised Code.

**SECTION IV:**

In order to protect and promote the public peace, health, safety, and welfare of the citizens of Trotwood and to promote efficiency in governmental operations, Council hereby declares that an emergency exists which requires the expedited implementation of this Ordinance.

**SECTION V:**

In accordance with Section 4-6 of the Charter of the City of Trotwood, Ohio, this Ordinance shall take effect immediately upon its adoption by Council.
