

**RESOLUTION NO. R23-48**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED “DRIVE-THRU TRICK-OR-TREAT” EVENT TO SERVE THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED THREE THOUSAND DOLLARS (\$3,000.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City; and

**WHEREAS**, the “Drive-Thru Trick-or-Treat” shall be a City-sponsored event to be held on Friday, October 27, 2023 from 6:00 p.m. to 8:00 p.m. at Madison Park, 301 South Broadway Avenue, Trotwood, Ohio.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council hereby determines that the “Drive-Thru Trick-or-Treat” shall be a City-sponsored event intended to serve the public purpose of fostering strong community relations, which serves a valid public purpose in the State of Ohio and in the City.

**SECTION II:** The Trotwood City Council hereby authorizes expenditures not to exceed Three Thousand Dollars (\$3,000.00) for the “Drive-Thru Trick-or-Treat” event for advertising, supplies for candy distribution, decorations, arts and crafts, volunteer supplies and other necessities. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
