

**RESOLUTION NO. R23-49**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED “COMMUNITY COMMUNICATIONS PROJECT” KICK-OFF EVENT TO SERVE THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED FIVE HUNDRED DOLLARS (\$500.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City; and

**WHEREAS**, the City is embarking on a Community Communications Project from July through December 2023 in order to produce a communications strategy to reach all members of the Trotwood community. During the kick-off event, residents will have the opportunity to get information on the project and sign up for upcoming in-person events; and

**WHEREAS**, the “Community Communications Project” kick-off shall be a City-sponsored event to be held on Friday, September 8, 2023 from 6:00 to 8:00 p.m. and Saturday, September 9, 2023 from 10:00 a.m. to noon at the West Campus of Goodwill Easterseals, 735 East Main Street, Trotwood, OH 45426.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

The Trotwood City Council hereby determines that the “Community Communications Project” shall be a City-sponsored event intended to serve the public purpose of fostering strong community relations, which serves a valid public purpose in the State of Ohio and in the City. The kick-off event shall be held on September 8, 2023 from 6:00 p.m. to 8:00 p.m. and on Saturday, September 9, 2023 from 10:00 to noon.

**SECTION II:**

The Trotwood City Council hereby authorizes expenditures not to exceed Five Hundred Dollars (\$500.00) for the "Community Communications Project" kick-off event for refreshments, service ware, and other necessities. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

**SECTION III:**

This Resolution shall take effect and be in full force from and after the date of its passage.
