

RESOLUTION NO. R23-78

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING AMENDING THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF TROTWOOD AND THE TEAMSTERS LOCAL UNION NO. 957 PREVIOUSLY APPROVED BY CITY COUNCIL BY RESOLUTION NO. R21-29 ON JULY 6, 2021, AND SUBSEQUENTLY AMENDED BY RESOLUTION NO. R21-49 ON NOVEMBER 1, 2021.

WHEREAS, a Collective Bargaining Agreement (“CBA”) between the City of Trotwood (the “City”) and Teamsters Local Union No. 957 (“Public Works”)(collectively, “the Parties”) was reached by the Parties for a three-year period of January 1, 2022 through December 31, 2024; and

WHEREAS, City Council passed Resolution No. R21-29 on July 6, 2021 approving the terms of the CBA as negotiated and authorizing the City Manager to execute the CBA on behalf of the City; and

WHEREAS, City Council subsequently passed Resolution No. R21-49 on November 1, 2021, providing Public Works a two and one-half percent (2.5%) wage increase each year of the three-year period of January 1, 2022 through December 31, 2024, which superseded and replaced the two percent (2.0%) wage increase as set forth in Article 22 of the CBA; and

WHEREAS, the City desires to provide Public Works a seven percent (7.0%) wage increase effective January 1, 2024 and a one-time wage adjustment by eight percent (8.0%), retroactive to October 6, 2023, as offered to Police Officers.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby approves the terms as set forth in the Memorandum of Understanding (“MOU”) attached hereto and incorporated herein as Exhibit A. Accordingly, City Council hereby authorizes the City Manager to execute the MOU attached hereto as Exhibit A, or another MOU in substantial conformity with the terms set forth therein, on behalf of the City.

MEMORANDUM OF UNDERSTANDING
BETWEEN THE CITY OF TROTWOOD, OHIO, AND THE
TEAMSTERS LOCAL UNION NO. 957

WHEREAS, a Collective Bargaining Agreement (“CBA”) between the City of Trotwood (the “City”) and the Teamsters Local Union No. 957 (“Public Works”)(collectively, “the Parties”) was reached by the Parties for a three-year period of January 1, 2022 through December 31, 2024; and

WHEREAS, City Council passed Resolution No. R21-29 on July 6, 2021 approving the terms of the CBA as negotiated and authorizing the City Manager to execute the CBA on behalf of the City; and

WHEREAS, City Council subsequently amended Article 22 of the CBA by Resolution No. R21-49 on November 1, 2021, providing Public Works with a two and one-half percent (2.5%) wage increase effective each year of the three-year period beginning on January 1, 2022, which rate superseded and replaced the two percent (2.0%) wage increase set forth in Article 22 of the CBA; and

WHEREAS, the City desires to provide Public Works a seven percent (7.0%) wage increase effective January 1, 2024 and a one-time wage adjustment by eight percent (8.0%), retroactive to October 6, 2023. Therefore, the Parties desire to amend Article 22, Section 22.1, for the remainder of the contract as follows:

1. Section 22.1. During the term of this Agreement, wages for employees shall be as follows:
