

**RESOLUTION NO. R24-07**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE “COMMUNITY COMMUNICATIONS PROJECT FUTURE SUMMIT: FINAL PRESENTATION OF COMMUNICATIONS STRATEGY AND TOOLKIT” EVENT TO SERVE THE PUBLIC PURPOSE OF PROMOTING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED SEVEN HUNDRED DOLLARS (\$700.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City; and

**WHEREAS**, the City held five (5) highly interactive focus sessions to discuss specific topics identified in the first stakeholder survey and discussions at the Public Launch. The purpose of this project is to produce a communications strategy to reach all members of the Trotwood community; and

**WHEREAS**, the final presentation will be held on Monday, February 5, 2024 from 11:30 a.m. to 1:30 p.m. at the West Campus of Goodwill Easterseals, 735 East Main Street, Trotwood, OH 45426.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council hereby determines that the final presentation of the “Community Communications Project” shall be a City-sponsored event intended to serve the public purpose of fostering strong community relations, which serves a valid public purpose in the State of Ohio and in the City. The event shall be held on Monday, February 5, 2024 from 11:30 a.m. to 1:30 p.m.

**SECTION II:** The Trotwood City Council hereby authorizes expenditures not to exceed Seven Hundred Dollars (\$700.00) for the final presentation of the “Community Communications Project” event for refreshments and other necessities. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.
