

**RESOLUTION NO. R24-16**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
APPOINTING LARRY BRYANT TO THE PUBLIC SAFETY  
COMMITTEE FOR THE CITY OF TROTWOOD.**

**WHEREAS**, by prior legislation, the Trotwood City Council established a Public Safety Committee and directed that the Public Safety Committee shall consist of nine (9) members comprised of the following: three (3) members of City Council; the City Manager; the Chief of Police; the Fire Chief; and three (3) residents of the City, which residents shall be appointed by the majority vote of Council; and

**WHEREAS**, by prior legislation, Resolution No. R23-12, Richard Eldridge was appointed to serve on the Public Safety Commission for a three-year term commencing March 6, 2023 and ending March 5, 2026; and

**WHEREAS**, Mr. Eldridge formally resigned from the Commission effective January 7, 2024; therefore, City Council must appoint a qualified elector of the City of Trotwood to serve on the Public Safety Commission for the remainder of the unexpired term of Mr. Eldridge.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** Larry Bryant, a qualified elector of the City of Trotwood, is hereby appointed to serve as a member of the Public Safety Committee for the remainder of the unexpired term of Richard Eldridge. Accordingly, Mr. Bryant shall serve on the Public Safety Committee beginning January 8, 2024 and ending March 5, 2026.

**SECTION II:** Mr. Bryant shall be administered his Oath of Office at such time that is mutually convenient for said elector and the Mayor.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.
