

**RESOLUTION NO. R24-35**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING A CITY-SPONSORED BIKE HELMET SAFETY AND SPRING FLING EVENT TO SERVE THE PUBLIC PURPOSE OF BUILDING STRONG COMMUNITY RELATIONS AND PROMOTING HEALTH AND WELLNESS, WITH EXPENDITURES NOT TO EXCEED SEVEN HUNDRED FIFTY DOLLARS (\$750.00).**

**WHEREAS**, the Trotwood City Council recognizes the importance of reinforcing strong community relations through City-sponsored activities and events; and

**WHEREAS**, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

**WHEREAS**, the Bike Helmet Safety and Spring Fling Event shall be a City-sponsored event to be held on Saturday, May 18, 2024, from 10:00 a.m. to 2:00 p.m. at Madison Park, located at 301 South Broadway Street in Trotwood, Ohio.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council hereby determines that the Bike Helmet Safety and Spring Fling Event is a City-sponsored event intended to serve the public purpose of building strong community relations and promoting the health and wellness of citizens, which serves a valid public purpose in the State of Ohio.

**SECTION II:** The Trotwood City Council hereby authorizes expenditures not to exceed Seven Hundred Fifty Dollars (\$750.00) for entertainment and other necessary supplies. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
