

**RESOLUTION NO. R24-58**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT TO PURCHASE A 2023 VAC-CON COMBINATION JET/VACUUM SEWER CLEANER (DEMO UNIT), MODEL V390H/1000, FROM BEST EQUIPMENT COMPANY THROUGH THE SOURCEWELL GOVERNMENT PURCHASING PROGRAM, CONTRACT #101221-VAC, FOR A TOTAL COST NOT TO EXCEED \$473,850.00.**

**WHEREAS**, the Vac-Con truck utilized by the Trotwood Public Works Department was involved in a traffic accident and is no longer operable; and

**WHEREAS**, the City of Trotwood Public Works Department needs a new Vac-Con Combination Jet/Vacuum Sewer Cleaner for the continuation of the high degree of service it provides to the citizens of the City of Trotwood; and

**WHEREAS**, this equipment, a 2023 Vac-Con Combination Jet/Vacuum Sewer Cleaner, Model V390H/1000, can be purchased from Best Equipment Company, Inc. through the Sourcewell Government Purchasing Program, Contract #1012,21-VAC and because this equipment is a demo unit, the company is offering a discount of \$142,978.40, for a total purchase price not to exceed \$473,850.00; and

**WHEREAS**, funds in an amount not to exceed the authorized purchase price have been appropriated and are in the process of being collected.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The Trotwood City Council authorizes the City Manager to enter into an agreement with Best Equipment Company, Inc. for the purchase of a 2023 Vac-Con Combination Jet/Vacuum Sewer Cleaner, Model V390H/1000. This agreement shall be in accordance with the Sourcewell Government Purchasing Program, Contract #101221-VAC, and shall be in an amount not to exceed \$473,850.00.

**SECTION II:** Funds have been appropriated in an amount not to exceed the authorized purchase price and are in the process of being collected.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.
