

RESOLUTION NO. R24-70

A RESOLUTION BY THE TROTWOOD CITY COUNCIL APPOINTING KARA LANDIS, CLERK OF COUNCIL, AS THEIR DESIGNEE TO ATTEND OHIO PUBLIC RECORDS AND OPEN MEETINGS LAW TRAINING IN ACCORDANCE WITH SECTIONS 149.43(E)(1) AND 109.43(B) OF THE OHIO REVISED CODE.

WHEREAS, Section 149.43(E)(1) of the Ohio Revised Code requires all local and statewide elected government officials or their designees to attend public records and open meetings training approved by the Ohio Attorney General; and

WHEREAS, Section 109.43(B) of the Ohio Revised Code provides that the elected officials or their appropriate designee shall attend three (3) hours of training for every term of office for which the elected officials were appointed or elected to the public office involved; and

WHEREAS, Kara Landis, Clerk of Council, successfully completed the Ohio Public Records and Open Meetings Law training on August 7, 2024, and

WHEREAS, Mayor Yvette F. Page, Vice-Mayor Tyna R. Brown, and Council Members Martha Clark, Rhonda C. Finley, Bettye L. Gales, Denise Moore, and Charles “Ron” Vaughn desire to appoint Kara Landis, Clerk of Council, as their designee for purposes of Sections 149.43(E)(1) and 109.43(B) of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: Trotwood City Council hereby appoints Kara Landis, Clerk of Council, as their designee to attend public records and open meetings training in compliance with the Ohio Public Records and Open Meetings Law training requirements prescribed by Sections 149.43(E)(1) and 109.43(B) of the Ohio Revised Code.

SECTION II: As the designee for the Trotwood City Council, Kara Landis has attended, and will continue to attend as needed, any requisite public records and open meetings training required by the Ohio Revised Code.

SECTION III: This Resolution shall take effect and be in force from and after the date of its passage.
