

**RESOLUTION NO. R24-72**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT THROUGH THE MIAMI VALLEY REGIONAL PLANNING COMMISSION'S INSTITUTE FOR LIVABLE AND EQUITABLE COMMUNITIES, WITH FUNDING FROM THE DAYTON FOUNDATION DEL MAR HEALTHCARE FUND.**

**WHEREAS**, the City of Trotwood is seeking to submit an application to become an "Age-Friendly Community" through the AARP Network of Age-Friendly States and Communities. This designation represents a multi-year planning effort focused on recognizing and enhancing the age-friendly and livable aspects of the community; and

**WHEREAS**, as part of this effort, the City of Trotwood has joined the Miami Valley Regional Planning Commission's Regional Livable and Age-Friendly Community Initiative, which aims to improve the quality of life for residents of all ages by promoting inclusivity, accessibility, and community engagement; and

**WHEREAS**, to support these initiatives, the City applied for and was awarded grant funds in the amount of \$15,000.00 from the Dayton Foundation Del Mar Healthcare Fund. These funds will be used to hire a consultant to conduct a comprehensive livability assessment for the City during the first year, which will help to identify the needs and opportunities for creating a more livable and age-friendly community; and

**WHEREAS**, the City Manager recommends that the Trotwood City Council authorize the City Manager to accept the grant funds from the Dayton Foundation's Del Mar Healthcare Fund through the Miami Valley Regional Planning Commission and to submit any Letters of Acceptance and/or any other documents required in furtherance of the receipt of these grant funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:**

The Trotwood City Council authorizes the City Manager to accept the grant funds awarded through the Miami Valley Regional Planning Commission's Regional Livable and Age-Friendly Community Initiative, with funding from the Dayton Foundation Del Mar Healthcare Fund, in the amount of \$15,000.00.

This Resolution shall take effect and be in full force from and after the date of its passage.


