

**RESOLUTION NO. R24-102**

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE MONTGOMERY COUNTY AUDITOR TO REMOVE AN ASSESSMENT LEVIED AGAINST A CERTAIN PARCEL OF PROPERTY FOR DELINQUENT CHARGES FOR REFUSE COLLECTION SERVICE FROM THE TAX DUPLICATE.**

**WHEREAS**, the City previously submitted delinquent charges for refuse collection service for certain parcels of property situated in the City of Trotwood, Ohio, to the Montgomery County Auditor for placement on the tax duplicate; and

**WHEREAS**, the assessment for the delinquent charges for refuse collection service was erroneously levied against the property known as 4988 Wolf Creek Pike, Parcel ID No. H33 02212 0003; and

**WHEREAS**, the City is requesting that this assessment levied in error be removed from the Montgomery County Auditor's tax duplicate.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** The City Manager or his designee is hereby authorized to request the Montgomery County Auditor to remove from the tax duplicate, an assessment levied in error for refuse collection service, which erroneous assessment is set forth in the document attached to and incorporated herein as Exhibit "A".

**SECTION II:** A copy of this Resolution, together with Exhibit "A" attached hereto and incorporated herein, shall be certified by the Clerk of Council to the Auditor of Montgomery County, Ohio, in order to remove the assessment levied in error.

**SECTION III:** This Resolution shall take effect and be in force from and after the date of its passage.


