

RESOLUTION NO. R25-06

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY-SPONSORED ANNUAL THREE-SHOW SUMMER CONCERT SERIES ENTITLED “MADISON PARK LIVE” TO SERVE THE PUBLIC PURPOSE OF BUILDING STRONG COMMUNITY RELATIONS, WITH EXPENDITURES NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000.00).

WHEREAS, the Trotwood City Council recognizes the importance of reinforcing strong community relations by City-sponsored activities; and

WHEREAS, City-sponsored activities and events help foster strong community relations, thereby serving a valid public purpose in the State of Ohio; and

WHEREAS, the “Madison Park Live” three-show summer concert series shall be a City-sponsored event to be held at Madison Park, 301 South Broadway Avenue, Trotwood, Ohio, and will feature nationally recognized talents; and

WHEREAS, this three-show summer concert series will provide music and dancing for the community, which serves a valid public purpose in the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The Trotwood City Council hereby determines that the annual three-show summer concert series entitled “Madison Park Live” is a City-sponsored event that will help foster strong community relations, thereby serving a valid public purpose in the State of Ohio and in the City.

SECTION II: The Trotwood City Council hereby authorizes expenditures not to exceed Fifty Thousand Dollars (\$50,000.00) for the “Madison Park Live” three-show concert series for talent booking fees and three (3) performances, rental of portable restrooms, tent rental and permits, trash receptacles, security, and other necessities. City Council hereby authorizes the City Manager to take all steps necessary to sponsor this event.

SECTION III: This Resolution shall take effect and be in full force from and after the date of its passage.
