A RESOLUTION BY THE TROTWOOD CITY COUNCIL APPOINTING A CITIZEN TO THE WARD 3 CITY COUNCIL VACANCY ACCORDING TO THE CITY CHARTER, ARTICLE 3, SECTION 3-4, ITEM (C): REMOVAL AND VACANCIES.

WHEREAS, the Ward 3 City Council seat has been vacated due to the resignation of Charles "Ron" Vaughn effective December 31, 2024; and

WHEREAS, Section 3-4 of the City Charter provides that a vacancy in the office of a Council Member shall be filled within sixty (60) days by a vote of a majority of the remaining members of Council and, because at the time of this appointment less than two (2) years remain of the unexpired term, the appointee shall serve the remaining term without election, ending December 31, 2025; and

WHEREAS, in accordance with Section 3-4 of the City Charter, a qualified elector, who is a resident of the City of Trotwood for not less than one (1) year and a resident of the Ward 3 district at the time of application, will be appointed to fill the Ward 3 City Council seat.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The Trotwood City Council hereby appoints <u>Milton J.</u>
<u>Pearson</u>, a qualified elector who is a resident of the City of Trotwood for not less than one (1) year and a resident of the Ward 3 district at the time of application, as the Council Member representing Ward 3.

SECTION II:

Milton J. Pearson shall be given their Oath of Office at the Regular Meeting to be held on Monday, February 3, 2025, or at such other time as is convenient for said appointee but prior to the February Regular Meeting.

SECTION III:

This Resolution shall take effect and be in force from and after the date of its passage.
